Sir,

Rani Dullaiya Homoeopathic Medical College Barhkedi Kalan, Bhadbhada Road Bhopal, Madhya Pradesh -462044, functioning since 2017 with intake capacity of 100 seats for B.H.M.S has applied for permission for A.Y. 2024-25. The College has submitted the Part I information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board have observed following shortfalls.

- Teaching Staff:** U.G and P.G degree and Affidavit of Dr. Somya and Dr. Raksha Tiwari are not uploaded.
- Miscellaneous:** Form 16 is not from Traces Portal, Copy of Form 16 of all the Teaching Faculties may be submitted for verification.
- Hospital:-**
 - No IPD and OPD cases are uploaded as the link given by the college is not opening. Therefore the college is directed to submit copies of first OPD & IPD Cases of the first day of every month for the last 12 months for verification.
 - ECG, USG & Diet register cannot be verified as the link given by the college is not opening. Copy of the same may be submitted for verification.

Considering the above observations and facilities available, MARBH has decided to issue Conditional Permission to Rani Dullaiya Homoeopathic Medical College Barhkedi Kalan, Bhadbhada Road Bhopal, Madhya Pradesh -462044 for BHMS course during the A.Y. 2024-25 with intake capacity of 100 seats.

All deficiencies noticed shall be rectified and vacancies may be filled up within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 seats for BHMS course shall be

treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT Govt. as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
