Sub: Application for Letter of permission for functioning of Rani Dullaiya Smriti Homoeopathic College and Hospital, Barkhedi Kalan, Bhadbhada Road, Bhopal – 462044, Madhya Pradesh for Admission in BHMS Undergraduate Course with Intake Capacity of 100 seats for BHMS for academic year 2025-26 – reg.

Sir/Madam,

Rani Dullaiya Smriti Homoeopathic College and Hospital, Barkhedi Kalan, Bhadbhada Road, Bhopal – 462044, Madhya Pradesh has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 07.05.2025 and 08.05.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

A. Hospital Functioning:

- Average OPD per day is 277 and IPD is 47% which is not as per MES, 2024 Regulations.
- Only 01 clinical teaching room out of 04 is available.
- General Physician 01 not available.

B. Teaching Faculty:

- Principal (Dr. Prem Nidhan Pal Chowdhary) is also working as Professor in department of Physiology, which is not as per MES, 2024 Regulations. Department of Physiology department has 02 Professors and Principal should be relieved from the duty of Professor and work independently in the capacity of Principal only.
- Department of Anatomy: Associate Professor 01 and Assistant Professor 01 not available.
- Department of Organon: Assistant Professor 01 not available.
- Department of Materia Media: Assistant Professor 01 not available.
- Department of Practice of Medicine: Assistant Professor 01 not available.
- Community Medicine, Research Methodology and Biostatistics: Associate Professor 01 not available.
- Department of Repertory: Assistant Professor 01 not available.

As evident from the above statement, a total number of seven teachers are deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES, 2024). Pursuant to F.No. :3-2/MARBH/NCH/2025-26/162-169 dtd. 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of

teachers for academic year 2025-26 only. After allowing relaxation of 10%, college has still a deficiency of three teachers. However, such a relaxed number of teachers should also be appointed at the earliest for smooth conduct of course.

C. Miscellaneous:

- a) College has applied for NABH accreditation.
- b) College is not accredited with NABL.
- c) Salary bank statement of staff and Form-16 from TRACES portal not submitted.

3. Considering the above observations during inspection, MARBH has decided to issue **Conditional Permission to Rani Dullaiya Smriti Homoeopathic College and Hospital, Barkhedhi Kalan, Bhadbhada Road, Bhopal – 462044, Madhya Pradesh with intake Capacity of 100 seats for academic year 2025 – 26 on the basis of following conditions:**


- i. Principal of college shall not hold charge of any other department as per MES, 2024 Regulations.
- ii. Deficiency of 03 teaching faculty shall be rectified within a period of 30 days.
- iii. Deficiencies A and C shall be rectified within a period of 30 days.

Deficiencies mentioned above shall be rectified within a period of 30 days and the compliance report shall be submitted to the undersigned, failing which conditional permission issued will be withdrawn without further notice.

4. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of UG seats shall be treated as All India Quota. Counselling for seats under all India quota shall be conducted by respective Counselling Authority of State/UT govt as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the state/UT.
5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
