Sir,

Rani Dullaiya Smriti Homoeopathy College and Hospital has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard requirements to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

A. Teaching Faculty: Total 26 full time teachers eligible against the requirement of 28.

- Dr. Vijeta Na Singh (Assistant Professor, Organon): Appointment letter is of Assistant Professor, Anatomy. Also MD degree not provided. The same may be provided.
- Dr. Pooja Singh (Professor, Gynecology/Obstetrics): DOJ as Lecturer: 13.06.2018. Experience of only Lecturer provided. No experience w.r.t Reader is provided. The same may be provided.
- Dr. Jayshree Pathak (Associate Professor, Practice of Medicine): DOJ as Assistant Professor: 30.06.2021. Appointment letter as Associate Professor not provided. Experience as Assistant Professor provided for only 02 years provided. Experience as Lecturer for 04 years required to be eligible for Associate Professor. The qualification and experience of the teaching since joining till date may be provided.
- Dr. Vinay Vikas Gupta (Associate Professor, Physiology): Appointment letter as Associate Professor not provided. Also experience of Lecturer for 4 years not provided. The same may be submitted for verification.
- Dr. Chetan K Shrivastav (Assistant Professor, Pathology) MD degree not provided. The same may be submitted for verification.

B. Miscellaneous: Form-16 not provided from TRACES portal.

C. Hospital Details: Hospital details as X-ray, ECG, USG and Lab investigations details not available in Part-1.


D. Case records: Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Records Room for academic purpose of students and follow up attendance of patients. Case sheets should have complete demographic details and contact details of patients. Diagnosis should be written in ICD 11 criteria

Considering the above observations, and facilities available, MARB has decided to issue **conditional permission to Rani Dullaiya Smriti Homoeopathy College and Hospital, Barkhedi Kalan, Bhadbhada Road, Bhopal, Madhya Pradesh - 462044 for permission with intake capacity of 100 seats for conducting BHMS course for the academic year 2023- 24.** All shortfalls mentioned shall be rectified within a period of 30 days or before counseling initiates whichever earlier, and compliance report shall be submitted to the undersigned, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.


The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
